Travel coordination to the School and time away from the workplace must be arranged by the recipient. The Scholarship(s) will be award by the Board of Regents Scholarship Committee.

The School, internationally recognized and attended, is the premier source of professional development in the industry. Its graduates are among the most successful professionals with outstanding park, recreation, and natural resources operations.

Scholarships shall be awarded for the purpose of providing opportunities to deserving recipients who provide documented need of financial assistance for professional development. Other criteria will apply.

Corporate Partner Scholarship applicants must meet the following criteria:

1. Applicants must be employed by a park, recreation, or natural resource-based agency.
2. Priority will be given to applicants from agencies with a demonstrated financial need and who are willing to pay a portion of the costs to attend the School. Financial need should be demonstrated through a budget, training or travel restriction mandated by an official higher than the agency director (i.e. city/county manager, mayor, etc.).
3. Applications must be accompanied by all the following:
  - a. A resume;
  - b. A letter from the applicant stating whether or not they are an NRPA Member, a commitment to attend both years of the School, rationale for seeking scholarship opportunity demonstrating the applicant's interest in furthering his or her professional skills and obtaining the most up-to-date technical and managerial education available in the parks, recreation, and natural resources industry;
  - c. Two reference letters on agency letterhead from individuals familiar with the applicant and his/her involvement in the park and recreation field and indicating support for the applicant's leadership, scholarship need, and potential for success in the field of parks and recreation; and

4. The application must be completed in its entirety and received by **October 15th** of the year prior to the School. Failure to complete the entire application and provide all required information may result in disqualification of consideration.
